SCSD2022 – Conferences and Exhibition

On the second day, in the morning, the focus will be on SMEs and insurances. The afternoon will be covered by the WEF with current topics as well as important persons and institutions. The second topic in the afternoon will be a new «Women in Cyber Sec Forum».

The Expert Tracks will be shortened in the morning and afternoon and the Best Practice Presentations will take place as before on two stages in the exhibition area throughout the event.

Theme parks will be expanded in the exhibition area. In addition, the two stages for innovation and education will be presented more prominently in this area.
